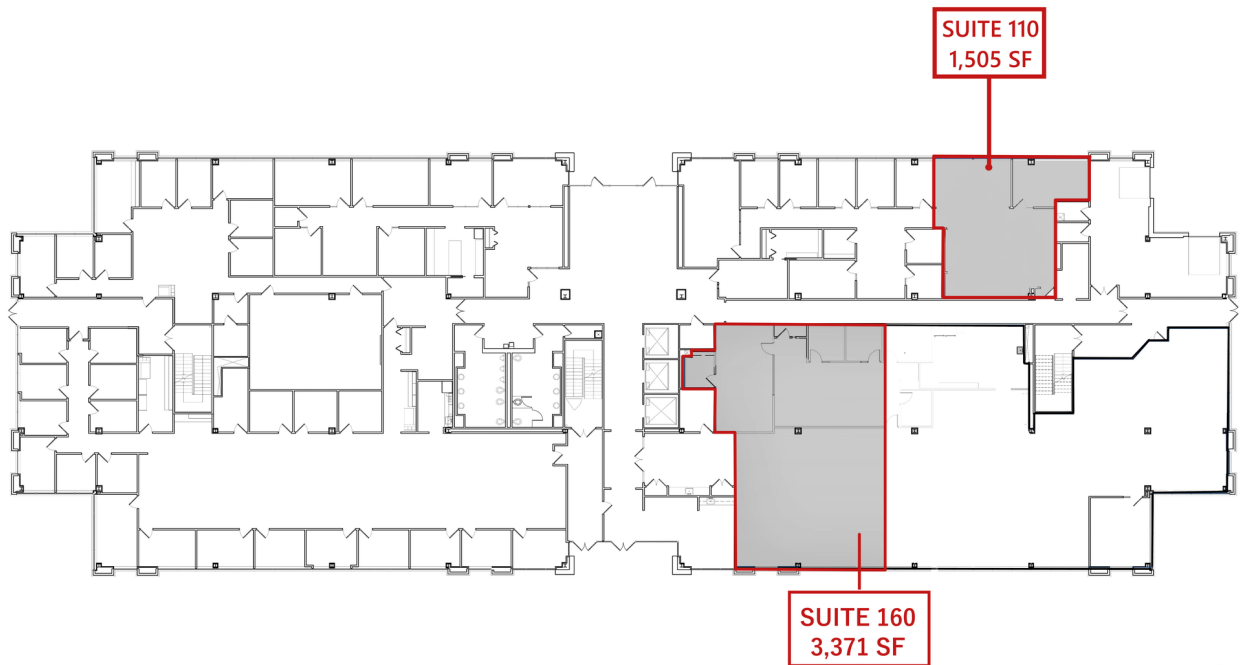

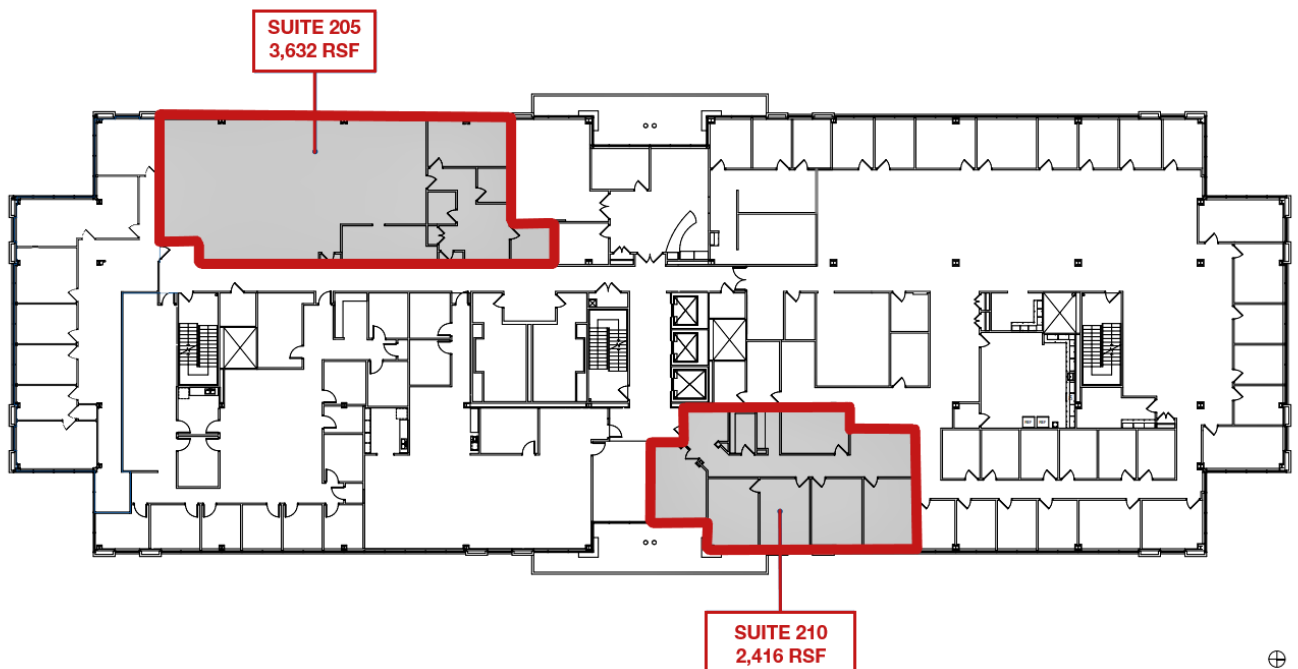

M001 | 11/06/20



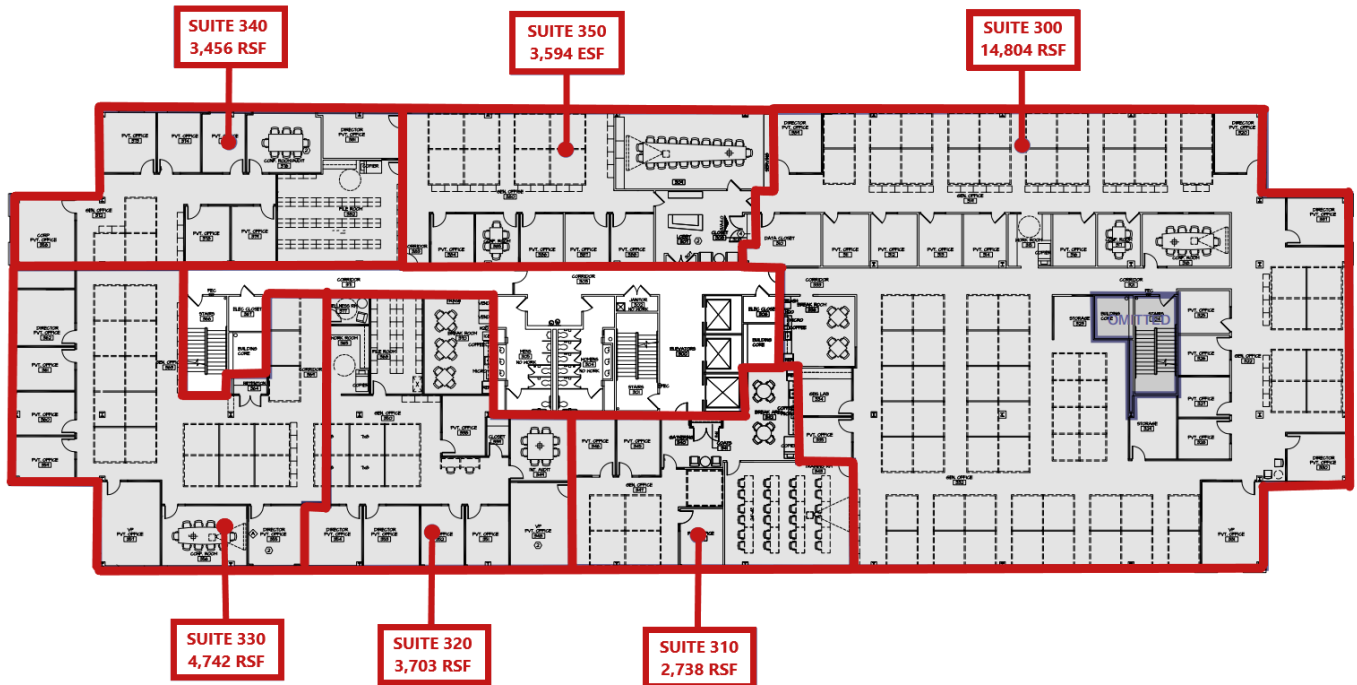
Second Floor

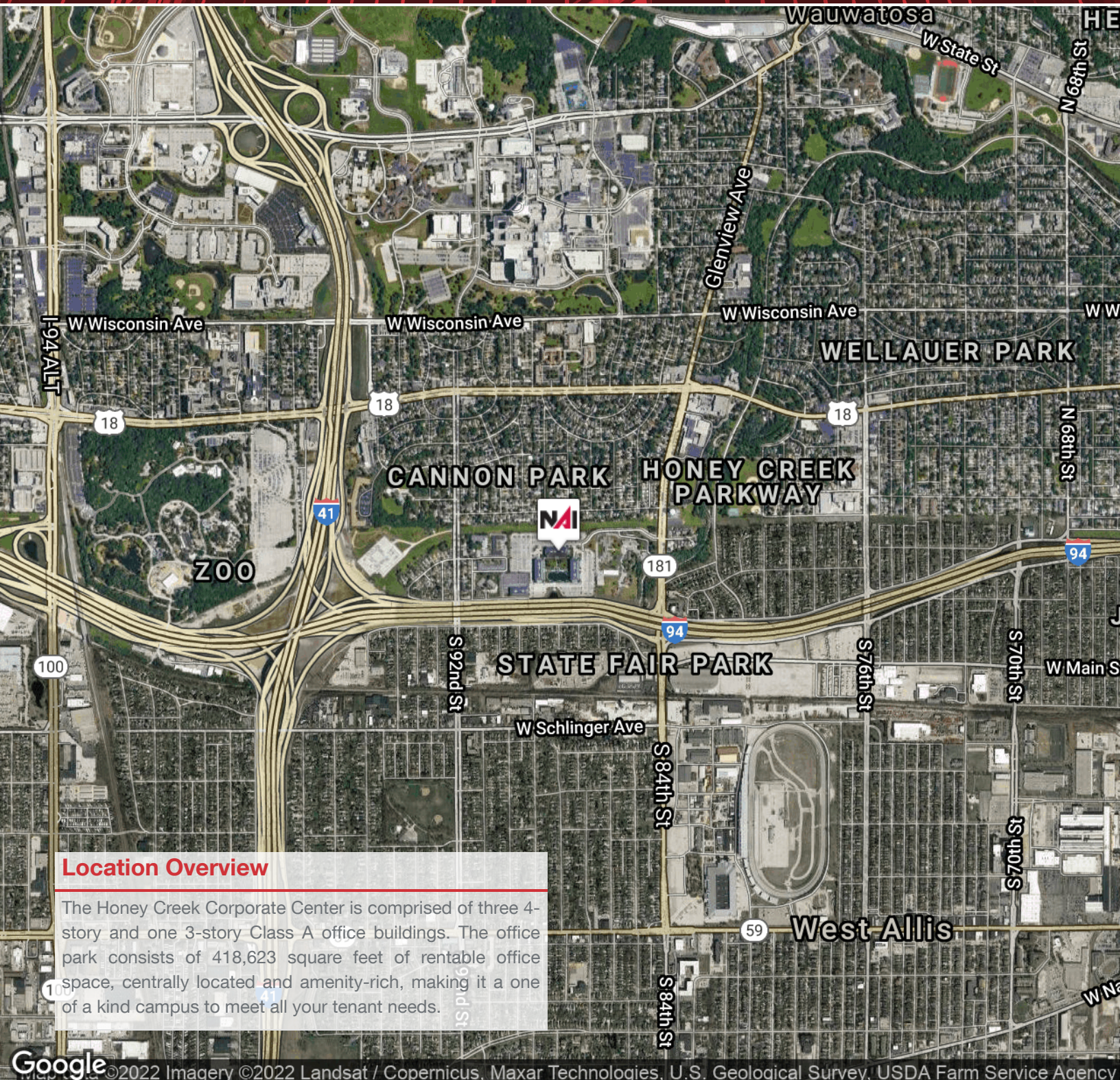


Fourth Floor

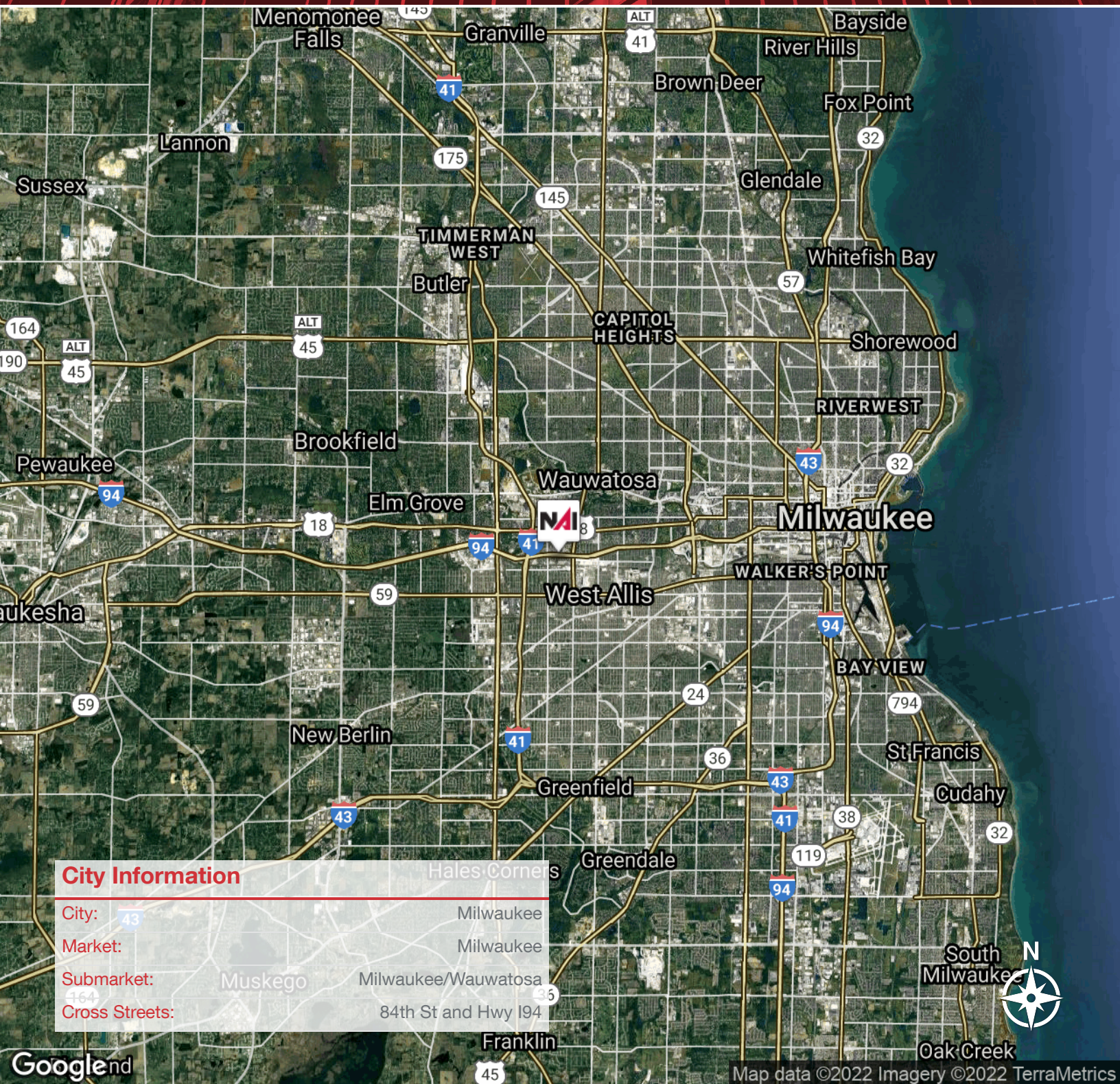
